

## CROSSPOINT CHRISTIAN SCHOOL PARENT AGREEMENT

Crosspoint Christian School (CCS) is committed to providing a Christ-centered education that prepares your child/children for life and service. We believe that the expectations outlined in Crosspoint Christian School policy are conducive to your personal growth and are in the best interest of Crosspoint Christian School as a whole. Our school expectations are based on Biblical principles, our local church support, our school history, and responsiveness to today's culture.

While we recognize that personal convictions from family to family may differ from that of Crosspoint, the purposes and ideals underlying them necessitate families be willing to modify their own personal preferences and standards of conduct while associated with CCS. If families cannot make needed modifications, we recommend that you consider a different learning environment.

**To maintain harmony with the home and Crosspoint Christian School, parents are required to:**

- ☐ **Support the school with your prayers and volunteer services.** Each family is required to complete a minimum of 15 service hours. You may opt out of this requirement by paying a \$225.00 fee.
- ☐ **Support Crosspoint Christian in all matters of discipline involving your student. Disciplinary policy is outlined in the student handbook and policy manual.**
- ☐ **Contact the person most immediately involved when you have questions involving discipline, policies, or procedures.**
- ☐ **Support Crosspoint Christian's *attendance policy* by committing to ensure that your student(s) are at school and on time each day.**
- ☐ **Support Crosspoint Christian in positive ways and not make negative or disparaging remarks about CCS in the community or on social media.**
- ☐ **Statement of Faith:** I have read and support Crosspoint Christian School's Statement of Faith.
- ☐ **Parent-Student Handbook:** I have read and agree to abide by the policies outlined in the Parent/Student Handbook. I hereby certify that I understand and accept the responsibilities as a Crosspoint Christian School Family and will adhere to and support the policies of Crosspoint Christian School for the duration of my association with CCS. I understand this includes school sponsored events and extra-curricular activities.
- ☐ **Technology and Electronic Media Acceptable Use:** I have read and discussed the Technology and Electronic Media Policy with my student and understand what is considered acceptable and unacceptable use of CCS computers and network. I give CCS administration permission to issue an account to my student. In accepting an account, my student is also accepting responsibility for using technology in a responsible and appropriate manner.
- ☐ **Student Standards of Conduct:** I have read and discussed the Student Standards of Conduct with my student. My student agrees to abide by the conduct code.
- ☐ **Tuition and Fees Policy:** I have received Crosspoint Christian's Tuition and Fee Policy and understand that after my student's third week of class there is no refund of tuition or forgiveness of the remaining annual balance of tuition for the academic year without School Board approval. For all intents and purposes a "seat" has been purchased for the entire academic year.

Additionally, I represent the information contained in my application is true, correct, and complete and further acknowledge and agree that any false statements or misrepresentations about my student(s) may be grounds for rejection of application or dismissal of my student(s) from Crosspoint Christian School.
